BHATIA BALRAKSHAK VIDYALAYA SOCIETY (BBRV) RULES AND REGULATIONS ACADEMIC YEAR 2024-25

- 1. Parents interested in seeking admission of their child (present student) in Shree Bhatia Bal Rakshak Vidyalaya Society(BBRV) Needs to fill the admission form by and submit by 31st May 2024. Admission will not be allotted after the said dates.
- 2. BBRV is meant only for the students of the Bhatia community.
- 3. Admission will be granted on the basis of availability of seats.
- 4. Every student needs to submit their school/college/university report card and the fee receipt along with the application form. Same will be verified before granting admission to BBRV.
- 5. BBRV Govenor and a responsible local guardian needs to endorse and validate the details of the student provided in the admission form.
- 6. Only completely filled forms will be accepted.
- 7. Students already enrolled in BBRV will get an extension/readmission to the new academic year subject to past behavioural/academic records of the student.
- 8. Once the admission is approved, the new admission student needs to pay Rs.1000/- as a security deposit for the year. In case of any damage done to the Boarding property will be deducted from this deposit money.
- 9. Students interested in seeking admission need to submit the authentic true financial, academic and health details in the form. In case of any lapses in the said information found later will call for cancellation of the students' admission.
- 10. Admission will be based on the approval and decision of the BBRV authorities.
- 11. Every student is expected to follow the daily time table which includes Prayers of BBRV, waking up time, study time etc. Failing to do so will call for a consequence.
- 12. Prayers are compulsory for all Students when present in the premises. Students need not argue for the same. Surprise visits by Trustees / Secretaries shall be done and absentees shall be viewed seriously. Attending Prayers every day is compulsory by every student. Failure to attend Prayers (twice a day) shall be punishable as per Boarding Rules.
- 13. Students enrolled are answerable to BBRV authorities. A students' admission stands cancelled from the Boarding in case the student leaves/suspended from the school/college/university for any unforeseen reason.
- 14. Any kind of misbehaviour in the Boarding premises or outside, disobedience, objectionable moral offence and above all disrespect and discourtesy to elders serving in the Boarding are sufficient causes for strict action and suspension.
- 15. A student detained/failed in School/college/university will be able to continue to use the Boarding facilities will be decided by BBRV authorities.
- 16. A student of the Bhatia community will follow the teachings of Bhagavad Geeta, Ramayana etc. BBRV always aims to inculcate Pushtimarg Sampraday sanskarsas and where possible.
- 17. Student who gets ill/sick will be given appropriate medication as per the doctor's instructions and if need be also treated in a hospital. In the process, if any unforeseen situation arises/happens BBRV will not be held responsible/liable for the same. The local guardian must immediately pick the child up from BBRV during any emergency. Normal Medical expense up to Rs.500/- will be borne by BBRV above than that will be taken care by the parents/local guardian.
- 18. During the stay, a student participates in a number of activities and while doing so, if a student elopes, gets lost while travel, drowns while swimming, hurts while in picnic or exercising, in that parent will not hold BBRV responsible.
- 19. Students needs to seek permission from the superintendent to go home once or twice maximum in a month. It will be the parent/local guardian's responsibility to pick and drop the child to BBRV. It will be the responsibility of the parent to send the student back to Boarding on the said date.
- 20. All the facilities in BBRV will be monitored and taken care by the BBRV authorities. Their decisions will be final and abiding to all.
- 21. There may be situations in which the support staff may not be available, wherein the students are expected to be independent and responsible. Students are expected to hold hands with each other, be caring and do all the domestic chores by themselves. The garden, compound, library, study room, sleeping room, dining area etc. are to be maintained clean at all times. The room in which the student lives should be cleaned along with the partner student by themselves.
- 22. Student will maintain peace while having food and study time. Students should not waste food. Students are expected to study in the place allocated to them.
- 23. Student needs to maintain physical hygiene on a day to day basis and keep their surroundings clean.

- 24. Student need to conserve the resources and hence switch off the lights and fans when not required.
- 25. Immorality, vandalism, smoking, drinking of alcohol, consuming drugs and malpractices such as theft, any kind of abuse are punishable offences and shall be dealt strictly to the extent of suspension of the student from BBRV.
- 26. A student failing to abide by the rules and regulations of BBRV, or mishandling Boarding property including walls, gadgets and devices will call for suspension from the Boarding furniture.
- 27. Before enrolling your child to any other extracurricular activities apart from regular school, permission to be taken from the superintendent of the Boarding.
- 28. Parents are requested to meet the Boarding authorities available on every Ist and last Sunday of every month with respect to your child's progress.
- 29. In any which situation, the student is supposed to reach the Boarding before the specified gate closer time dinner time or else will have to give an apology valid written reason for the same. An invalid reason will call for a consequence in this regard.
- 30. Admission of the student to a school college/university will be the sole responsibility of the parent. BBRV will only provide a safe stay and good food arrangements.
- 31. Students enrolled in the Boarding are not allowed to serve places to earn financial benefits.
- 32. Student admitted will have to give his updated mobile number to the superintendent. Usage of Mobile from 11 pm to 6 am will not be permitted. Each student in possession of Personal Computers/Laptops/I-Pods etc. has to inform superintendent all its details (like Mobile Number, Service Operator, Prepaid/Post-paid etc.) before the same is brought in Boarding premises. Violating the rules shall be seriously viewed.
- 33. Usage of mobile, iPod, radios etc. without knowledge of superintendent are strictly prohibited as per the Rules and Regulation of the Boarding. Therefore, prior permission for the same is compulsory by each student.
- 34. Computer and Internet usage is strictly for study purpose only. No usage of Computer between 11.00 pm to 6:00 am shall be permitted.
- 35. Use of Boarding Name and its Logo shall not be permitted for creating personal Email Ids or in Social Media Networking Sites. Violating the Rules shall be strictly viewed.
- 36. Sleeping hours are restricted as decided and intimated by the Boarding and violation of the same shall be seriously viewed.
- 37. Attendance in respective School/College and Tuition Class shall be compulsory for every student. Each student has to compulsorily furnish Attendance Certificate from his respective School/College and Tuition Class to Superintendent for each of the terms. Failure to furnish periodical Attendance Certificate shall be serious ly viewed.
- 38. Applications forwarded for Scholarship to one or more trusts and the Scholarship received from such, trusts should be informed to the Superintendent. All Scholarship applications (while in Boarding) should be routed through the Superintendent and any sum received there against shall be intimated to Boarding first.
- 39. Local Parents shall be informed about behaviour and negative progress of the concerned student as and when possible. Indiscipline and mischievous activities of the students shall be not being tolerated Local Parents shall undertake to take wilful custody of suspended students when informed and Boarding shall not be responsible once such Student leaves premises after his suspension
- 40. Students aiming for higher Educational Courses shall be permitted to do the course affiliated training on stipend basis or free. However, outside jobs are strictly prohibited. Such students shall have to leave the Boarding immediately.
- 41. Students will look after their own belongings with utmost care. The Boarding will not be responsible for any loss of goods for e.g. Mobiles, Calculators, books, stationery, shoes etc.
- 42. Students must realize that all of them are bonded by Bhatia community and hence live together in harmony with brotherhood. In case of any kind of bullying observed shall be dealt strictly.

We have hereby read all the above mentioned rules and regulations carefully. We shall abide by the same from time to time.
